Essay Topic: School Discipline and Prison

School discipline of black and brown children and youth has been the topic of discussion for the past several years, but according to the findings of U.S. Department of Education, Office of Civil Rights in its data collection for reporting year 2012, disciplinary policies in public schools are harsher on black and brown students than any other race of students. Sanctions were reported as grossly disproportionate, particularly expulsion and suspension of black and brown students. The cliché known as the school-to-prison pipeline has been discussed and criticized by civil and legal organizations, including the American Civil Liberties Union (ACLU), the National Bar Association (NBA), and the American Bar Association (ABA). All these organizations have concluded, to some extent, that the policies in public schools that criminalize students for non-violent violations of school policies and without due process are leading our black and brown youth into the court system that may likely lead them into the prison system.

For a perspective from a young black man, you should review Kyle Thompson's story posted on the ACLU website. The ACLU notes that Kyle is part of a national trend where children are funneled out of public schools and into the juvenile and criminal justice systems. <u>Your Essay Assignment</u>: Based on the topic of this essay and the resources provided to you below, you should provide an analysis of the current disciplinary policies and laws for preschool, elementary, or high school black and brown students, and provide your recommendations for alternative policies or laws that can be implemented to deal with the issue of plugging the school-to-prison pipeline.

Closed Universe of Resources

You MUST use the following resources to support your analysis of this essay issue. You do <u>not</u> have to use all the resources provided but must adequately incorporate sufficient resources to support your position.

- 1) You may use any article from the Arkansas Law Review, Volume 68 (2015).
 - a. This issue of the Arkansas Law Review contains articles from a special symposium issue addressing education and this essay topic.
 - b. You do NOT have to use all the articles in the essay.
 - c. You may use the footnote resources from any of the articles.
- 2) The following books are resources for your consideration:

Essay Format Guidelines

Your essay must follow the following format, which will be considered in the decision process.

- 1) The essay should be in law review format, double-spaced with footnotes.
- 2) Footnotes must be single-spaced.
- 3) The footnotes may be in Bluebook or ALWD format.
- 4) The essay must be in Times New Roman, 12-font, with 1-inch margins on all sides.
- 5) The essay must NOT exceed 10 pages in length on 8.5x11 paper.
